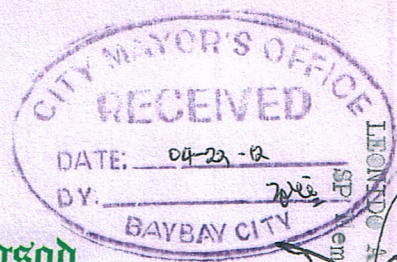

AN ORDINANCE AMENDING SECTION IV OF THE CITY ORDINANCE NO. 008 S. 2011  
OF BAYBAY, FIXING THE RATE OF ULTRA SOUND AND LABORATORY FEES OF  
THE BAYBAY MEDICAL DIAGNOSTIC CENTER, AND OTHER HEALTH SERVICE  
FACILITIES OF RHU'S 1 AND II.

Be it ordained by the Sangguniang Panlungsod of Baybay, Province of  
Leyte, assembled that:

SECTION 1.- Baybay Diagnostic Center was made possible for the purpose of  
helping all Baybayanos avail the services of a diagnostic center;

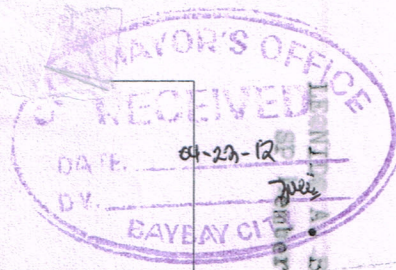

SECTION III.- (A) Those persons certified by our CSWD duly approved by the Mayor as indigent persons will be given 50% of charge on all fees at the Baybay Diagnostic Center;

(B) A discount of 20% will be given to Senior Citizens, students, all elected and appointed city Officials and employees, and Barangay Officials of the City of Baybay.)

(C) A 50% discount will be given to employees of the Local Government Unit who will submit to a yearly medical check-up and certified by the Mayor.

SECTION IV.- Fees will be paid to the City Treasurer or duly authorized representative and present the official receipt to the Diagnostic Center. The said fees will be deposited to the General Fund of the City of Baybay.

SECTION V.- any person violating this ordinance shall, upon conviction be fined in the amount of One Thousand Pesos (P 1,000.00) minimum ) to Two Thousand Pesos (P2,000.00) maximum or an imprisonment of not less than five (5) days and not more than fifteen (15) days or both depending upon the discretion of the court.

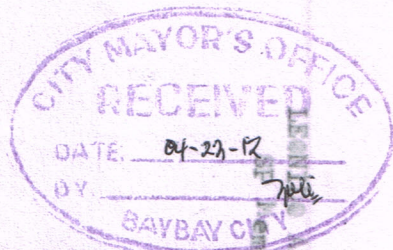
