Resolution No. 027 s. 2010

A RESOLUTION ADOPTING THE SUPPLEMENTAL BUDGET FOR CALENDAR YEAR 2010 OF THE CITY OF BAYBAY IN THE AMOUNT OF SIXTY-THREE MILLION SIX HUNDRED THOUSAND PESOS (P63,600,000.00).

Presented for consideration was the Supplemental Budget No. 1, CY 2010, submitted by the Honorable City Mayor, Michael L. Cari, with the total amount of SIXTY-THREE MILLION PESOS (P63,600,000.00) which the body after perusal and thorough examination thereof, deemed that the aforementioned budget was in accordance with law.

RESOLVED as it hereby does RESOLVE, to that the Appropriation Ordinance be as hereby is adopted to wit;

APPROPRIATION ORDINANCE No. 001 s. 2010

AN ORDINANCE ADOPTING THE SUPPLEMENTAL BUDGET NO. 001 FOR THE CALENDAR YEAR 2010 OF THE CITY OF BAYBAY IN THE TOTAL AMOUNT OF SIXTY-THREE MILLION SIX HUNDRED THOUSAND PESOS (P63,600,000.00).

Be it ordained by the Sangguniang Panlungsod of the City of Baybay in session assembled, that;

Section 1.- The sum of Sixty-three million six hundred thousand pesos (P63,600,000.00) is hereby declared for supplementary budget from the current year's local income, IRA increase for additional appropriation of the different offices.

Section 2 - This ordinance shall take effect upon its approval.

Enacted, March 8, 2007.
