CITY ORDINANCE NO. 001
S. 2008

AN ORDINANCE DECLARING JUNE 16, 2008 AND EVERY 16TH DAY OF JUNE THEREAFTER AS CITY FOUNDATION DAY AND A SPECIAL NON WORKING DAY.

SPONSORED AND INTRO BY HON. SP MEMBER ERNESTO M. BUTAWAN & HON. SP MEMBER MARGARITA C. CARI.

WHEREAS, the City of Baybay acquired its corporate existence by virtue of Republic Act 9389 which was ratified overwhelmingly by its people in a plebiscite held on June 16, 2007;

WHEREAS, on June 16, 2008 is the first anniversary of Baybay as a City;

WHEREAS, it is the intention of the City and its officials to hold festive activities on June 16, 2008 and every 16th day of June thereafter in celebration of its founding day;

NOW THEREFORE, by virtue of the power vested in the Sangguniang Panlungsod under Republic Act 7160 be it enacted in this August body, an ordinance to be known as;

I. TITLE:

AN ORDINANCE DECLARING JUNE 16, 2008 AS FIRST FOUNDING DAY AND EVERY 16TH OF JUNE THEREAFTER AS CITY FOUNDATION DAY AND DECLARING IT FURTHER A SPECIAL NON WORKING DAY BOTH IN PUBLIC AND PRIVATE SECTORS.

II. COVERAGE:

This ordinance shall cover the entire territory of the City of Baybay.

III. APPLICABILITY OF LABOR CODE AND ADMINISTRATIVE CODE OF THE PHILIPPINES

The provisions of the Labor Code and Administrative Code of the Philippines respectively with respect to "holiday" pay shall be applicable insofar as payment of wages/salaries to employees both in private and public sectors.

IV. EFFECTIVITY:


This ordinance shall take effect immediately after approval by the Sangguniang Panlalawigan of the Province of Leyte.

ENACTED: March 24, 2008.



CARRIED UNANIMOUSLY.


