CITY ORDINANCE NO. 003 S. 2009

AN ORDINANCE AMENDING CITY ORDINANCE NO. 001 S. 2007 ESTABLISHING THE
LINE ROUTE OF ALL PUBLIC UTILITY VEHICLES WITHIN THE CITY OF BAYBAY
PARTICULARLY SECTION 3, PARAGRAPHS A, B, C, D, E, F and SECTIONS 4,
PARAGRAPH C & D.

INTRO. & SPONSORED BY: HON. SP MEMBER LEONIDO A. BERAY & ALL
MEMBERS PRESENT.

BE IT ORDAINED, by the Sangguniang Panlungsod of Baybay City in session, that:

SECTION 1. Title - This ordinance shall be called the Line Route Ordinance for all Public
Utility Vehicles within the Poblacion of Baybay City.

SECTION 2. Definition of Terms - The following terms shall be defined as:

- a. **Public Utility Vehicle** - all motorized vehicle carrying cargoes and
passengers offered to the public.
- b. **Passengers** - the riding public of public utility vehicle, whether they pay
their fare or not;
- c. **Bus Terminal** - the facility owned and operated by the city where public
utility vehicle is temporarily housed in order to solicit passengers and
cargoes passengers and cargoes.
- d. Unloading area the identified places for unloading of passengers and
cargoes except the Bus Terminal area.

Line Route - the assigned route for all public utility vehicles going in and out of the Bus Terminal.

SECTION 3. The line route as designated by this proposed ordinance are hereby determined.

A. To Ormoc City Route and Northern Barangays

A-1. All Public Utility vehicles coming from the terminal will pass through the Tres Martires St. left turn to 30 de Diciembre St., turn right to the A. Mabini St. to the exit route.

A-2. All passenger vans, multicabs, jeepneys, tricycles and habal-habal whose passenger(s) have cargoes to be picked up from the business establishments which are located outside the designated exit route are allowed to deviate to pick up cargoes only, provided, a pass slip is issued by the Office of the Traffic Enforcer, at the Bus Terminal area. For this purpose, the pass slip shall indicate the alternate route to be taken by the vehicles in going back to the exit route.

B. To Maasin City Route and Southern Barangays

B-1. All Public Utility Vehicles will pass through the Tres Martires St., then turn right to Magsaysay Ave. then to the exit route.

B-2. All passenger vans, multicabs, jeepneys, tricycles and habal-habal whose passenger(s) have cargoes to be picked up from the business establishments which are located outside the designated exit route are allowed to deviate to pick up cargoes only, provided, a pass slip is issued by the Office of the Traffic Enforcer, at the Bus terminal area. For this purpose, the pass slip shall indicate the alternate route to be taken by the vehicles in going back to the exit route.

C. To Tacloban City Route Including Eastern Barangays

C-1. All Public Utility Vehicles from the Terminal will pass through the Tres Martires St., then turn right to the M. L. Quezon St., turn left to the E. Jacinto St., to the exit route.

C-2. All passenger vans, multicabs, jeepneys, tricycles and habal-habal whose passenger(s) have cargoes to be picked up from the business establishments which are located outside the designated exit route are allowed to deviate to pick up cargoes only, provided, a pass slip is issued by the Office of the Traffic Enforcer, at the Bus Terminal area. For this purpose, the pass slip shall indicate the alternate route to be taken by the vehicles in going back to the exit route.

D. From Ormoc City to the Bus Terminal.

D-1. All Public utility vehicle, Buses, vans will pass to the reclamation area then to the Bus Terminal from Monday to Saturday, but on Sundays and church Holidays, they will pass through A. Mabini St., then turn left to the Magsaysay Avenue turn right to A. Bonifacio St. to the Bus Terminal.

D-2. Multicabs, Jeepneys, tricycles and Habal-habal shall pass through A. Mabini St., turn left to N. L. Fernandez St., turn right to A. Bonifacio St., to the Bus Terminal and or A. Mabini St., turn left to G.H. del Pilar St., turn right to A. Bonifacio St. to the terminal.

D-3. Multicabs, tricycles, jeepneys and Habal-Habal are allowed to deviate from their original route in order to transport student passengers to their respective schools even without pass slip.

E. From Maasin City Route Including Southern Barangays to the Bus Terminal

E-1. Public Utility Vehicles will pass through Magsaysay Ave., turn left to A. Bonifacio St. to the Bus Terminal.

E.2 Public Utility vans, multicabs, jeepneys, tricycles, Habal-habal whose passengers are students and passengers who have cargoes to be delivered in the business district in the city are authorized to deviate from their entry route and will pass either E. Jacinto St., turn left to 30 de Diciembre St. to their respective schools for the students and pass to the M. Moraza St. to the Magsaysay Ave. and or Tres Martires St. turn right either M.L. Quezon Ave. or R. Magsaysay St. turn left A. Bonifacio St. to the terminal and for passenger multicabs, jeepney, tricycles, habal-habal whose passengers have cargoes to be delivered in the business district are allowed to deviate from their entry route only for the purpose of unloading cargoes and the owner then to M. L. Quezon St. to A. Bonifacio St. and to the Terminal, without securing pass slip.

F. From Tacloban City Route Including Eastern Barangays to the Bus Terminal.

F-1. All Public Utility buses, vans, will pass through E. Jacinto St., turn right turn 30 de Diciembre St. turn left A. Mabini St., to the reclamation area, to the Bus Terminal from Monday to Saturday. However, on Sundays and church holidays, they will pass through E. Jacinto St. turn right to 30 de Diciembre St. left turn A. Mabini St, left turn to Magsaysay ve., turn right to A. Bonifacio St., to the Bus Terminal.

F-2. All Public Utility multicabs, jeepneys, tricycle and Habal-habal will pass through the E. Jacinto St., turn right to 30 de Diciembre St. left turn to the M. Moraza St., or Tres Martires St. turn right to Magsaysay Ave., turn left to A. Bonifacio St., to the Bus Terminal.

F-3. All Public Utility vans, multicabs, jeepneys, tricycle, Habal-habal may deviate from their route for the benefit of the student passenger and for those who have cargoes to be delivered in the business district even without the required pass slip, then to the exit route which can be either M. Moraza St. or Tres Martires St. turn right to Magsaysay Ave. turn left to A. Bonifacio St., to the terminal.

SECTION 4. Unloading Areas of Passengers and Cargoes before Arriving at the Terminal

A. From Ormoc City route and Northern Barangay - All public utility vehicles can unload passengers and cargoes at designated areas along A. Mabini St. and N.L. Fernandez; A. Mabini St., and G.H. del Pilar St., A. Mabini St. and Magsaysay Ave., or at the reclamation area.

B. Multicabs, tricycles and Habal-habal can unload passengers and cargoes at designated areas along A. Mabini St., and N.L. Fernandez St., A. Bonifacio St. and N.L. Fernandez St., and near the Caltex Station.

C. From Maasin City Route and Southern Barangays

C-1. All Public Utility vehicles can unload passengers, cargoes along Magsaysay Ave., along the streets of Zone 22 and 30 de Diciembre St. to be identified by signage.

C-2. Students are given the privilege to be delivered to their respective school without securing pass slip.

D. From Tacloban City Route and Eastern Barangays

D-1. All Public Utility vehicles can unload passengers and cargoes along E. Jacinto St., 30 de Diciembre St., along M. Moraza St., along Tres Martires St. or M.L. Quezon St. identified by signage.

D-2. Students are given the privilege to be transported to their respective schools without securing pass slip.

SECTION 5. Enforcement Period

This ordinance shall be enforced between 6:00 am 7:00 pm.

SECTION 6. Prohibited Acts

It shall be considered as a violation of this ordinance of a public utility vehicle driver, conductor, dispatcher or any other person authorized by any operator or his representative to solicit or accept passengers, cargoes and allow them to board their public utility vehicles in any place of the poblacion (Zone 1-23) of Baybay other than their respective destinations outside of the poblacion (Zone 1-23) proper.

SECTION 7. Penalty

Violators of any provision of this ordinance shall be fined in the sum of P700.00 for Bus, P500.00 for jeepneys, multicab and V-Hire vans and P100.00 for tricycle and Habal-habal for the first offence;

Second offence - the same amount shall be collected as fine, suspension of franchise permit and the privilege to use the facility of the Bus Terminal, for tricycle, and for all other public utility vehicles suspension of the privilege to use the Bus Terminal for one day;

Third offence - any violator after the second offence shall be called habitual violators and shall be imposed the following penalty:

- A. **Bus** - P2,000 plus suspension of their privilege to use the terminal facility for one week and five (5) days imprisonment for the driver & conductor.
- B. **Jeepneys, Vans** - P1,000 plus suspension of their privilege to use the terminal facility for one week and three (3) days imprisonment for the driver.
- C. **Tricycle & Habal-habal** - P500 plus suspension of their privilege to use the terminal facility for one week and three (3) days imprisonment for the driver.

The primary person liable to pay the fine is the registered owner or operator of the public utility vehicle except if the violator is not employed or crew of the latter and in such a case the violator himself is liable to pay the fine as provided in first paragraph hereof.

SECTION 8. Separability Clause

If any portion or section of this Ordinance shall be declared unconstitutional or invalid it shall not invalidate the whole ordinance.

SECTION 9. Repealing Clause

All existing ordinances, rules and regulations, which are inconsistent to this ordinance are hereby repealed, amended or modified.

SECTION 10. EFFECTIVITY

This ordinance shall take effect 15 days after its approval

RESOLVED, FURTHER, to let certified copies of this ordinance be furnished to Sangguniang Panlalawigan of Leyte and all other offices concerned for their information and guidance.
