CITY ORDINANCE NO. 004

AN ORDINANCE REPEALING MUNICIPAL ORDINANCE #06 s. 1986 AND ESTABLISHING OR DESIGNATING THE BAYBAY SPORTS COMPLEX (ALSO KNOWN AS THE OVAL) BESIDE THE BAYBAY 1 CENTRAL SCHOOL AS THE "FREEDOM PARK" WHERE DEMONSTRATIONS, MEETINGS, RALLIES AND OTHER FORMS OF MASS ACTION MAY BE HELD WITHOUT A PRIOR PERMIT AND FOR OTHER PURPOSES.

Be it ordained by the Sangguniang Panlungsod of Baybay City that:

SECTION 1: Title and Scope- This ordinance shall be known as an ordinance establishing or designating the Baybay Sports Center (also known as the oval) at the Baybay 1 District this city as the "Freedom Park" where demonstration, meeting, rallies, marches and other form of mass action and to air grievances against the government or any organization may be held sans a prior permit.

SECTION 2: Declaration of Policy- It is a declared policy of the local government unit to establish or designate a "freedom park" located within the city of Baybay in compliance with the provisions of the Public assembly act of 1985, otherwise known as P.D.880;

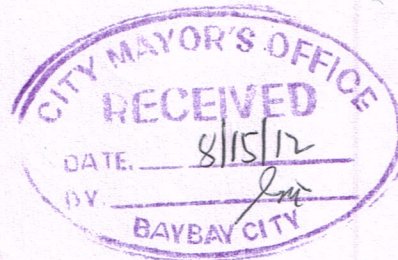
SECTION 3. Permits Not Necessary: the herein established or designated "freedom park" is the hub for peaceful assembly to petition for redress of grievance and/or "Center" for free speech where anyone who cares to speak can do so without securing a permit.

SECTION 4. Permit Needed - All areas not designated or established as "freedom park" utilized for other purposes need to secure a written permit from the local chief executive and have to pay corresponding fee for the use of such government facility and the Local Chief Executive has the full authority to grant said permits provided such activity will not hamper or endanger lives or properties and should be in consonance with the provisions of the laws and ordinances of the city and of the government.

SECTION 5. Notice Required: - In order to avoid conflicts of schedule and to provide maintenance of peace and order by the law enforcers, sponsors or organizers of demonstration, rally, meeting or assembly to be held at the "Freedom Park" are hereby required to notify in writing the local authorities or the office of the Local Chief Executive at least five (5) working days prior to the scheduled activity.

SECTION 6. All resolution, Ordinance, rules and regulation inconstant with this ordinance are hereby repealed or rescinded accordingly.

SECTION 7. This ordinance shall take effect upon its approval.
