AN ORDINANCE AMENDING MUN. ORDINANCE NO. 005 S. 2001 FIXING THE RATE ON ULTRASOUND AND LABORATORY FEES FOR BAYBAY MEDICAL DIAGNOSTIC CENTER PARTICULARLY SECTION 4 OF SAID ORDINANCE.

Be it ordained by the Sangguniang Panlungsod of Baybay, Province of Leyte, in session assembled, that:

- SECTION I -** Baybay Diagnostic Center was made possible for the purpose of helping all Baybayanos avail the services of a diagnostic center;
- SECTION II.-** After comparison of all laboratory fees in Tacloban City, Ormoc City and Baybay City the following rates are hereby considered and adopted:

SECTION III.- (A) Those persons certified by our CSWD duly approved by the Mayor as indigent persons will be free if charges on all fees at the Baybay Diagnostic Center.

-B) A discount of 20% will be given to Senior Citizens, students all elected and appointed Barangay Officials of the City of Baybay.

SECTION IV.- Fees will be paid to the City Treasurer or duly authorized representative and present the official receipt to the Diagnostic Center. The said fees will be deposited to the General Fund of the City of Baybay.


SECTION V.- Any person violating this ordinance shall, upon conviction be fined in the amount of One Thousand (P1,000.00) Pesos as minimum to Two Thousand (P2,000.00) Pesos maximum or an imprisonment of not less than five (5) days and not more than fifteen (15) days or both depending upon the discretion of the court.

SECTION VI.- Separability of Provisions.- If any provisions of this ordinance shall be declared invalid, illegal or unenforceable in any respect, the validity, legality of the remaining provisions contained therein shall not in any way affect or impair the whole provisons of this ordinance.


SECTION VII. - Effectivity.- This ordinance shall take effect upon its approval.
