CITY ORDINANCE NO. 007 S. 2008

AN ORDINANCE ADOPTING THE BPI SPECIAL QUARANTINE ORDER NO. 01, SERIES OF 2007, AND REGULATING THE ENTRY OF PALM TREES, ORNAMENTAL PLANTS AND FRUIT-BEARING TREES INTO THE TERRITORIAL JURISDICTION OF BAYBAY CITY AND PROVIDING PENALTIES THEREOF.

WHEREAS, the city of Baybay is one of the main producers of copra and other coconut products in the province of Leyte;

WHEREAS, the Department of Agriculture (DA) issued through the Bureau of Plant Industry (BPI) Special Quarantine Order No. 01, series of 2007, Amendment to Administrative Order No. 03, series 2005, (Declaring Coconut Leaf Beatle, Brontispa Longissimus (Gestro) Invasive Quarantine Pest of Coconut, Coco nucifera and providing measures to Regulate and Prevent its Spread)

WHEREAS, the Malacañang issued an Executive Order No. 664, Establishing emergency measures to control and eradicate the spread and damage of Brontispa in the Philippine coconut industry and designating the Philippine Coconut Authority (PCA) as the lead agency for the purpose.

WHEREAS, the aforementioned Executive Orders are designed to protect and preserve the coconut industries of the coconut producing provinces in our country;

NOW THEREFORE, pursuant to the mandate of the Local Government Unit under the Local Government Code of 1991, a City Ordinance No. 007 is hereby promulgated as follows:

Section 1 - DEFINITION OF TERMS

4. Quarantine - the enforced isolation for a fixe period of

persons, ships, or goods arriving from places infected with contagious disease, or of any persons who have been exposed to such

infection.

5. Checkpoints - is the place established by the LGU of the City

of Baybay for purposes of checking the entry of coconut planting materials, ornamental plants and fruit bearing trees to determine if the same are carriers of the coconut leaf beetle, otherwise known as the Brontispa

longissima.

Section 2. - PROHIBITED ACTS

1. Transporting to the territorial jurisdiction of Baybay City coconut seedlings and other palm species, ornamental plants and other planting materials inspected and identified by the DA as carrier of the pests known as Brontispa Longissima.

2. Transporting of coconut leaves, nuts identified to be infected with coconut beetle within the territorial jurisdiction of Baybay City.

Section 3. EXEMPTION

1. Entry to or transporting within the city of Baybay any of coconut planting materials and other ornamental plants is allowed provided there is a permit to transport issued by the PCA/DA authorized personnel or any Quarantine officer.

Section 4. PENALTY

a) First offense - confiscation of illegally transported planting materials, any violator should pay a fine of P2,000.00.

b) Second offense - confiscation of illegally transported plants, and violators should pay a fine of P2,500.00 and imprisonment of not more than 10 days but not less than 5 days.

Section 5 - EFFECTIVITY

This ordinance shall take effect immediately.
