AN ORDINANCE IMPLEMENTING THE COLOR CODING SYSTEM OF ALL PASSENGER  
TRICYCLES WITHIN THE CITY OF BAYBAY INCLUDING SUBURBAN AREAS

WHEREAS, the City of Baybay, being a newly created city in the province of Leyte has a  
number of passenger tricycle s plying in different routes from the poblacion area going to the  
barangays in the North South and East and within the downtown premises;

WHEREAS, it is our desire to streamline the travel of our passenger tricycles and set a  
proper system of control for purposes of giving a smooth and orderly flow of trffic in our city;

NOW THEREFORE, to enforce a solution addrsed to the problems issue, an ordinance  
is hereby formulated, implementing the color coding system of passenger tricycles plying within  
the City of Baybay premises including the suburban areas.

SECTION 1. TITLE.-

This ordinance shall be called AN ORDINANCE IMPLEMENTING THE  
COLOR CODING SYSTEM OF ALL PASSENGER TRICYCLES PLYING WITHIN THE CITY  
OF BAYBAY PREMISES INCLUDING THE SUBURBAN AREAS.

SECTION 11- . DEFINITION OF TERMS

- a. Passenger tricycles - refer to all motorized tricycles carrying  
passengers plying in every route in the City of  
Baybay premises and including suburban areas.

| b. | Passengers | - refer to the riding public availing the services of all motorized tricycles whether they pay their fare or not.  |
| c. | Color Code | - is the assigning of specific color of passenger tricycles traveling their respective routes, going to the North, South, East and within the downtown premises. |
| d. | Line Route | - refers to the route assignment given specifically to each passenger tricycles traveling in and out of the terminal.  |

#### SECTION 111 COLOR CODES

- |    |        |  |
|----|--------|--|
| a. | WHITE  | - is the color assigned specifically to the North - bound passenger tricycles including the suburban areas..   |
| b. | RED    | - is the color assigned specifically to the South - bound passenger tricycles, including Pomponan and other suburban areas.  |
| c. | BLUE   | - is the color assigned specifically to the East - bound passenger tricycles, including Ciabu, Mapgap and other suburban areas.                                      |
| d. | YELLOW | - is the color specifically to the DOWNTOWN passenger tricycles including Barangays Cogon, Sto. Rosario, LEYECO . Suboffice, and crossing of Hipusngo, Biasong road. |

#### SECTION IV - PROHIBITED ACTS

1. Soliciting of passengers or cargoes by motorized tricycles without any color code.
2. The plying of tricycles outside from their color corded route - except "pakyaw" private trip there must be a special

#### SECTION V. PENALTY -

Violation of any provision of this ordinance shall be penalized with:

- a. a fine of not less than Two Hundred Fifty (P250.00) Pesos for first offense.
- b. a fine in the amount of Five Hundred (P500.00) Pesos for the second offenses.
- c. a fine in the amount of One Thousand (P1,000.00) Pesos for the third offense.
- d. Cancellation of franchise for habitual violation.

The person liable for the penalty of a fine on specified above are as follows:

- a) The registered owner or operator of the passenger tricycle if the said vehicle is not painted with the color prescribed.
- b. The driver if the said vehicle plies an area outside of his jurisdiction and without a special permit from the Traffic Management Officer.
