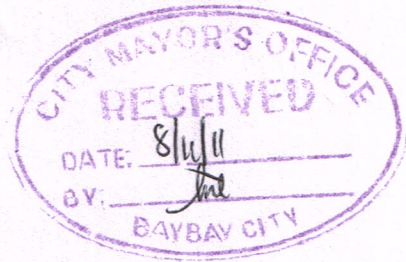

AN ORDINANCE AMENDING **ARTICLE X ADMINISTRATION AND ENFORCEMENT SECTION 31** OF THE CITY ORDINANCE NO. 02 S. 2010, BETTER KNOWN AS "AN ORDINANCE ESTABLISHING AND ADOPTING THE COMPREHENSIVE ZONING ORDINANCE OF THE CITY OF BAYBAY".

Presented for consideration was the opulent wish of this August body to amend the **Article X** Section 31 of the City Ordinance No. 02 s. 2010, which this body desired to be corrected or amended.

On motion of the Hon. SP Member Ernesto M. Butawan duly seconded by the Hon. SP Member Cristelo S. Loreto; be it

RESOLVED, as it hereby does RESOLVED, that following City Ordinance be, as hereby is, adopted, to wit:

AN ORDINANCE

AMENDING **ARTICLE X-ADMINISTRATION AND ENFORCEMENT "SECTION 31"** OF THE CITY ORDINANCE 02 s. 2010 BETTER KNOWN AS "AN ORDINANCE ESTABLISHING AND ADOPTING THE COMPREHENSIVE ZONING ORDINANCE OF THE CITY OF BAYBAY".

Be it enacted by the Sangguniang Panlungsod of the City of Baybay, Province of Leyte, in session assembled, that:

Section 1. - Article X Administration and Enforcement of the City Ordinance No. 02 s. 2010. Is hereby amended , to read:

"SECTION 31. A.- **Creation of the City Zoning Administration Division (ZAD)**. The administration and enforcement of this Ordinance shall be vested in the City Zoning Administration Division, which is hereby created. It shall be directly under the Office of the City Administrator. The office personnel shall have the following competencies such as but not limited to office administration, spatial planning, policy research and monitoring, geodetic survey and similar qualifications, proficiency in the operation of mapping software, and other competencies needed to ensure the efficient and effective operation of the ZAD."

The creation of such positions shall be subjected to existing rules and regulations of the Civil Service Commission and other pertinent laws on public personnel.

SECTION 31. B.- "Meanwhile, pending creation and appointment of the Zoning Administration and Division of its officer, the City Planning Division Officer

shall act as the Zoning Officer task to implement the function until such office is officially created."


Section 2. - This amended ordinance shall take effect upon the approval.

Approved, August 1, 2011.


RESOLVED, FURTHER, to let certified copies of this amended ordinance be furnished to the offices concerned for their information and guidance.


