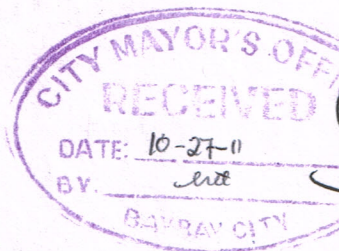

City Ordinance No. 013 s. 2011

AN ORDINANCE TEMPORARILY CLOSING RIZAL AVE., EXT. IN FRONT OF THE
EXISTING PUBLIC MARKET TO ACCOMMODATE THE AMBULANT PEDDLERS WITHIN
THE HOURS OF 3:00 P.M. TO 7:00 P.M.

WHEREAS, it has been a perennial problem of the City Government of Baybay, the
rampant presence of ambulant peddlers who peddle in the surrounding premises of the public
market and in other crowded public places of the city proper;

WHEREAS, these ambulant peddlers are not renting any stall at the public market
and despite repeated demands by the LGU officials to secure a stall where they could sell
their produce or products, however, they failed and continuously fail up to this time opting
instead to peddle outside;

WHEREAS, ambulant peddling is against the local ordinance of the City as they are
considered illegal vendors however, the city government is mindful that its implementation or
enforcement is not a good sight to see in public where local authorities are chasing illegal
vendors and often than not engaged in physical violence just to implement and enforce the
ordinance;

WHEREAS, the city officials have devised ways and means to regulate the ambulant
peddlers by giving them a specific area/place where to peddle their produce or product under
certain terms and conditions;

WHEREFORE, it is RESOLVED, as it hereby does RESOLVE, to promulgate this
ordinance to regulate the ambulant vendors in the city;

SECTION 1. AREA ALLOTTED FOR AMBULANT VENDORS.

The area to be allotted to the ambulant vendors is a portion of Rizal Ave., extension
in front of the public market. This street is part of the reclamation area owned by the city
government.

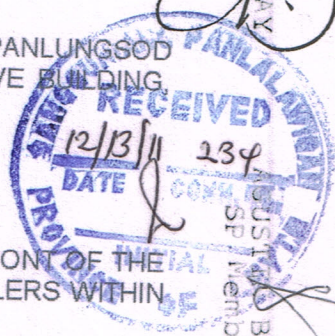
SECTION 2. TIME ALLOTTED TO THE AMBULANT VENDORS.

The ambulant vendors are given to use a portion of Rizal Ave. Extension in front of
the public market from the hours of 3:00 o'clock in the afternoon to 7:00 o'clock in the
evening. For this purpose the said portion is hereby declared temporarily closed from any
motor vehicles within the hours of 3:00 P.M. to 7:00 P.M. The Market Supervisor is directed
to submit within 5 days to the City Mayor and the Sangguniang Panlungsod the sketch plan
of the area to allotted with the ambulant vendors.

SECTION 3. PAYMENT OF CASH TICKETS.

In lieu of a monthly rental for the use of the temporary use of the area allotted, the
ambulant vendors are required to pay on a daily cash tickets to the city government in the
amount of not more than P200.00 daily;

SECTION 4. PROHIBITED ACTS

The following are considered prohibited acts for the purpose of this Ordinance, to wit:

1. Peddling outside the established area before, during or after the allotted time;
2. Refusal to pay cash tickets;
3. Putting up makeshift store in the area or placing tables for the display of their produce or products.

SECTION 5. PENALTY.

Violation of any of the prohibited acts mentioned, the offender is subject to the following penalty:

- a) First offense - shall be penalized by a fine of not less than P1,000.00, without imprisonment;
- b) Second offense - shall be penalized by a fine of not less than P1,500.00 without imprisonment;
- c) Third offense - shall be penalized by a fine of P2,500.00 and an imprisonment of not less than 5 days but not more than 15 days.

SECTION 6. REPEALING CLAUSE.

All ordinances, executive orders and implementing rules which are contrary to the above-provisions are hereby declared repealed.

SECTION 7. EFFECTIVITY.

This ordinance shall take effect immediately after its approval.
