AN ORDINANCE ADOPTING THE ELECTRONIC MEDICAL RECORD (EMR)-BASED HEALTH INFORMATION SYSTEM THROUGH THE "eHealth TABLET (Technology Assisted Boards for LGU Efficiency and Transparency) for informed Decision – making of LGUs" or eHATID LGU PROJECT IN THE CITY HEALTH OFFICE OF THE CITY OF BAYBAY.

WHEREAS, Section 17 (b) (2) (iii) of Republic Act No. 7160, otherwise known as the Local Government Code of the 1991 provides that "health services, which include the implementation of programs and projects on primary health care, maternal and child care, and communicable and non-communicable disease control services; access to secondary and tertiary health services: purchase of medicines, medical supplies, and equipment needed to carry out the services herein enumerated" are the duties and responsibilities of the local government units;

WHEREAS, the State likewise declares that the vesting of duty, responsibility and accountability in local government units (LGU) shall be accompanied by a provision for reasonably adequate resources to effectively carry out their functions;

WHEREAS, eHATID LGU project was approved by Department of Science and Technology Philippine Council for Health Research and Development (DOST PCHRD) Governing Council during its 136th Meeting last 17 June 2014 and falls under the National Unified Health Research Agenda (NUHRA) priority areas in information Communication and Technology (ICT) for Health Program;

WHEREAS, the eHATID LGU project complies with the PhilHealth Outpatient Benefit Package Plus (OPB+) otherwise known as the TSeKAP-Tamang Serbisyo para sa Kalusugan ng Pamilyang Pilipino electronic information system requirements and reporting procedures in support of the Universal Health Care/Kalusugan Pangkalahatan, E-gov Master plan and Integrated Government Philippines (IGov Phil);

WHEREAS, the CITY OF BAYBAY seeks to enhance its capability to govern, and has recognized the role of information Communication and Technology (ICT) to ensure effective and efficient governance and delivery of basic health services to its constituents and commits in promoting community development through the use of ICT for effective and efficient governance in their locality;

WHEREAS, the CITY OF BAYBAY has manifested its intent to be considered as one of the beneficiaries of the eHATID LGU project through a Letter of intent (LOI) and

correspondingly executed a Memorandum of Understanding (MOU) attesting to its commitment and support to implement and sustain the program;

NOW, THEREFORE, BE IT ENACTED BY THE SANGGUNIANG PANLUNGSOD, IN SESSION DULY ASSEMBLED, THAT:

SECTION 1. City Health Office of the CITY OF BAYBAY adopts the eHATID LGU EMR software and its cloud-based technical support to comply with the national health data reporting systems and standards as provided in the policies and programs of the National eHealth Steering Committee of the Department of Health (DOH) and Department of Science and Technology (DOST);

SECTION 2. The City Health Office of the CITY OF BAYBAY is mandated to issue internal policies and guidelines incorporating into the RHU/CHO and LGU workflows THE eHATID EMR software requirements and its cloud-based technical support to enhance health information system data processing procedures, data security and reporting procedures;

SECTION 3. The ordinance and the corresponding LGU internal policies and guidelines provides the mandate and expresses the LGU's intent to sustain the eHealth information System operations notwithstanding any change in the LGU's leadership; and to endorse to the next LGU administration the eHealth related policies, programs, equipment including access codes to softwares and databases to ensure the continuity of health services to its constituents;

SECTION 4. The CITY OF BAYBAY adopts PhilHealth Circular 10 s. 2012 Section V Subsection G which provides the details for the disposition and allocation of the PhilHealth Per Family Payment (PFP) as follows:

"Eighty percent (80%) of PFP is for operational cost and shall be divided as follows"

- a. *Minimum of forty percent (40%) for drugs and medicines Philippine National Drug Formulary (PNDF);*
- b. *Maximum of forty percent (40%) for supplies, equipment (i.e ambulance, ambubag, stretcher, etc.). information technology (IT equipment specific for facility use needed to facilitate reporting and database build up), capacity building/or staff, infrastructure or any other use, related necessary for the delivery of required service referral fees for diagnostic services if not available in the facility."*

The allocation for information technology shall include all expenses that can facilitate reporting and database build-up such as IT tools and equipment, internet subscription/access specific for facility use or payment for encoding services of PCB data in case hiring of additional personnel is necessary for initial database build-up or maintenance.

SECTION 5. The Sanggunian Secretary is hereby ordered to furnish a copy of this Ordinance to National eHealth Steering Committee (DOST PCHRD, Bicutan Taguig City and DOH Knowledge Management Information Technology Service (KMITS) Rizal Ave. Sta Cruz Manila) for their information.


SECTION 6. Repealing clause. All cities ordinances, resolutions, implementing rules and regulations, and executive orders, or parts thereof, which are inconsistent with the provisions of this Ordinance are hereby repealed and/or modified accordingly.

SECTION 7. Separability Clause. If, for any reason, any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.


SECTION 8. Effectivity Clause. The Ordinance shall take effect immediately upon its approval.
