CITY ORDINANCE NO. 17, S. 2017

AN ORDINANCE DECLARING EVERY 27th DAY OF DECEMBER OF EVERY YEAR AS BINAYBAYON FESTIVAL DAY, FURTHER DECLARING IT AS THE HIGHLIGHT PRESENTATION OF THE BAYBAY CITY SOCIO-CULTURAL ACTIVITIES.

Whereas, the Binaybayon Festival, which is celebrated every year, tells the story of the customs and traditions of the City of Baybay;

Whereas, the Binaybayon Festival is the presentation of the city in its participation in cultural events throughout the region;

Whereas, all Baybayanons, here and abroad, recognize the Binaybayon Festival as the symbol of what is good and wholesome in the traditional way of life of our andestors; and

Whereas, our socio-cultural activities offer the best venue and platform to further depict this traditionally rich event and present it to as many people as possible;

NOW THEREFORE, be it RESOLVED, as it is hereby RESOLVED, that in session assembled, the Sangguniang Panlungsod of the city of Baybay enacts this ordinance declaring every 27th day of December of every year as Binaybayon Festival Day and further declaring it as the highlight presentation of the Baybay City Socio-Cultural Activities.

Section 1. Title. This shall be known as the Ordinance declaring the 27th day of December of every year as Binaybayon Festival Day and further declaring it as the highlight presentation of the Baybay City Socio-Cultural Activities.

Funding Support. This event shall become a regular annual activity Section 2. of the city and shall be supported with an initial budget of THREE HUNDRED THOUSAND (P300,000.00) pesos for the succeeding annual presentations shall be prepared by the BTIPO and submitted to the office of the mayor for inclusion in the annual appropriations of the city.

Repealing Clause. All previous ordinances, resolutions and Section 3. issuances inconsistent with this ordinance are deemed amended or repealed.

Effectivity. This ordinance takes effect immediately after its Section 4. approval and publication.

RESOLVED FURTHER, that certified copies of this ORDINANCE be furnished to the Sangguniang Panlalawigan, Province of Leyte, and other offices concerned for their information and appropriate action.
