MUNICIPAL ORDINANCE NO. 001 S. 2007

AN ORDINANCE AMENDING MUN. ORDINANCE NO. 005 S. 2001 FIXING THE RATE ON ULTRASOUND AND LABORATORY FEES FOR BAYBAY MEDICAL DIAGNOSTIC CENTER.

Section 4. - Fees will be paid to the Municipal Treasurer or duly authorized representative and present the official receipt to Baybay Medical Diagnostic Center.

Section 5. - any person violating this ordinance shall upon conviction be fined in the amount of One Thousand Pesos (P1,000.00) as minimum to Two Thousand Pesos (P2,000.00) maximum or an imprisonment of not less than 5 days and not more than 15 days or both depending upon the discretion of the court.

Section 6. - Separability of Provisions- Ig any provision of this ordinance shall be declared invalid, illegal or unenforceable in any respect the validity, legality and enforceability of the remaining provisions contained therein shall not in any way affect or impair the whole provisions of this ordinance.

Section 7. - Effectivity - This ordinance shall take effect upon its approval.

Enacted, January 23, 2007
