A RESOLUTION ENACTING AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO.013 S. 1993. AN ORDINANCE FOR ANTI-LITTERING AND ITS PENALTIES.

WHEREAS, Municipal Ordinance No. 93-013, an anti-littering ordinance have been passed by the former Sangguniang Bayan of the municipality;

WHEREAS, this body wants to give more teeth to the said ordinance by amending its penalties.

WHEREFORE, on motion of the Honorable SB Member Deogracias E. Pernitez, duly seconded by the Honorable SB Members Vicente G. Veloso and Edgardo R. Ompoy; be it

RESOLVED, FURTHER, to let certified copies of this ordinance be furnished all concerned, for implementation, information and compliance.

MUNICIPAL ORDINANCE NO. 002-S. 2002

AN ORDINANCE AMENDING MUN. ORDINANCE NO. 013-S. 1993, AN ORDINANCE FOR ANTHITTERING, PROHIBITING ANY PERSON OR PERSONS FROM IMPROPER URINATING, THROWING OR ANY REFUSE OR GARBAGE, CIGARETTE BUTTS, MATCH STICKS, INTO THE CANALS AND ON THE STREETS OR IN ANY PUBLIC PLACES NOT APPROPRIATE WITHIN THE MUNICIPALITY OF BAYBAY, LEYTE, PRESCRIBING PENALTIES THEREOF AND FOR OTHER PURPOSES.

Be it ordained by the Sangguniang Bayan of Baybay, Province of Leyte, is session assembled, that:

Section 1.- It shall be prohibited for any person or persons to throw litters, such as cigaret builts, match sticks, pieces of paper, plastic wrappers, etc... refuse or garbage, improper urinating into the streets, canals or other places within this municipality, which look unclean and likely to permit decay, decomposition or bercome obnoxious or a menace to the health of the people, except in a trash can or fly-proof receptacle, provided, that the throwing of cigaret butts, garbage

or refuse and/or improper urinating should be constructed receptacle so as to prevent the contents from spilling, flying about, or otherwise, scattering.

Section 2. - It shall be the duty of every establishment, vendor, home or office to provide themselves with trash cans or garbage cans, and the duty of every home to have a compost pit wherein they should throw the refuse in the trash can or garbage can when it is full or necessary.

Section 3. - Penalties - Any person or persons violating any provision of this ordinance shall upon the first offense fined One Hundred Fifty Pesos (P150.00)and for the succeeding offenses a fined of Five Hundred Pesos (P500.00) and community services as defined in R.A. 9003.

Section 4. - Repealing Clause. - Any resolution, ordinance, rule, or regulation not in conformity to this ordinance is hereby repealed or modified accordingly.

Section 5. this ordinance shall take effect upon its approval.
