MUNICIPAL ORDINANCE NO. 009 S. 2005

AN ORDINANCE FIXING THE MINIMUM FARE OF ALL PASSENGER TRICYCLE AND MOTORCYCLE TRANSPORT VEHICLES GOING TO THE INTERIOR BARANGAYS OF COGON, HIBUNAWAN, MAGANHAN, AND IGANG,, THIS MUNICIPALITY.

WHEREAS, barangays Hibunawan, Cogon, Maganhan, Igang and their respective inner most sitios are interior barangay of this municipality;

WHEREAS, the medium public transportation used in said barangays are tricycle, and motorcycle;

WHEREAS, the minimum or fix fare collected by said public transport are determined by means of comparison from, the fare issued by the Land Transportation Franchising Regulatory Board;

WHEREAS, the nature or condition of the roads in these interior barangays are not at par with the national road and often time contributed high maintenance expense on the vehicles traveling these road compared to those which are traveling in national road;

WHEREAS, the services of increases in the oil (fuel) added the high cost of maintenance of operator/driver of the public transport plying the route of these barangays;

WHEREAS, per public hearing conducted on April 15, 2005 the public interposed no objection of the proposed increase

NOW, THEREFORE,

Be it ordained by the Sangguniang Bayan of the Municipality of Baybay, Province of Leyte. in session assebled, that:

Section 1.- the present fare collected by these public transport from the riding public since 2001 are as follows:

Section 111. Penalties - Any violation of this established or approved minimum fare of public transport plying to said route shall be penalized with a fine of One Thousand Pesos (P1,000.00) and/or imprisonment, not more than thirty (30) days at the discretion of the court.

Section IV. Effectivity Clause - This ordinance shall take effect 15 days after the approval of the Sangguniang Panlalawigan.
