MINUTES OF THE 8th REGULAR SESSION OF THE SANGGUNIAN PANLUNGSOD OF BAYBAY CITY, LEYTE HELD AT THE SESSION HALL ON FEBRUARY 29, 2016.

RESOLUTION NO. 054 S. 2016

A RESOLUTION ENDORSING BACK TO THE OFFICE OF THE CITY MAYOR THE COMPLAINT AGAINST THE MANAGER OF THE BAYBAY CITY WATER DISTRICT.

WHEREAS, the Sangguniang Panlungsod received an endorsement from the City Mayor Honorable Carmen L. Cari to act on the anonymous letter complaint against Mr. Cyril Arradaza, the General Manager of Baybay City Water District which was referred to her office by the Office of the Ombudsman (Visayas) for appropriate action;

WHEREAS, the content of the anonymous letter complaint delve on the failure of the General Manager to improve the services of the water district;

WHEREAS in various occasions the Sangguniang Panlungsod also received information and verbal complaints from different consumers and entities regarding the services of the water district especially on the potability of the water its pressure as a matter of fact results of different testing laboratories indicate the presence of residue and the water has not met the "bacteriological standard" for a safe water.

WHEREAS, these circumstances (the endorsement of the anonymous letter complaint, the information and verbal complaints and results of the laboratory testing) impel the Sangguniang Panlungsod to send formal letter of invitation to Mr. Cyril Arradaza, the General Manager of the Baybay City Water District to a conference with the Sangguniang Panlungsod members on its session day on February 29, 2016 to shed light on the anonymous letter complaint and to the various complaints of the consumers and the different laboratory results;

WHEREAS, the letter was received by his office and despite said receipt he failed and refused to attend the session without any reason at all and did not reply to the letter of invitation as he always did in the previous invitations;

WHEREAS, the General Manger, Mr. Cyril Arradaza in several occasions as born out from the record also failed to attend personally the session of the Sangguniang Panlungsod despite formal invitation to him to discuss matters pertaining to the services of the water district to its consumers;

WHEREAS, the apparent and continuous snab of the General Manager, Mr. Cyril Arradaza on the previous and latest invitation made by the Sangguniang Panlungsod to him to discuss with the Sanggunian on matters relating to the services of the water district to its consumers is an indicia of his unwillingness to observe inter-agency cooperation and coordination.


WHEREFORE, on motion of Honorable Eden C. Butawan duly seconded by all members present; be it:

RESOLVED, as it hereby does RESOLVE, to endorsed back to the Office of the City Mayor the complaint against the Manager of the Baybay City Water District.


RESOLVED, FURTHER, to let certified copies of this resolution be furnished to the Hon. Carmen L. Cari, City Mayor for her information appropriate action.
