RESOLUTION NO. 068 S. 2016

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR CARMEN L. CARI TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH A JUNKSHOP IN THE CITY TO SUPPORT THE RECOVERY OF NON-BIODEGRADABLE MATERIALS AND SERVE AS A FUNCTIONAL MATERIALS RECOVERY FACILITY.

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code and Republic Act No. 9003, otherwise known as the Ecological Solid Waste Management Act of 2000, mandated that Local Government Units shall be primarily responsible for the implementation and enforcement of requirements for an ecological solid waste management system within their respective jurisdictions;

WHEREAS, R.A. 9003 further requires LGUs to set waste diversion goals that shall be achieved through re-use, recycling and composting, and other resource recovery activities;

WHEREAS, in order to achieve the waste diversion goals, it requires the establishment of a materials recovery facility or MRF as a facility designed to receive, sort, process, and store compostable and recyclable materials efficiently and in an environmentally sound manner.

WHEREAS, junkshops had been in the business to recover non-biodegradable and recyclable waste from households and institutions for sale into industries that process these materials into other re-usable products, and can hereby support LGU-Baybay in the recovery of recyclable materials and to serve as a materials recovery facility;

On motion of Honorable Cristelo S. Loreto duly seconded by Honorable Leoncio P. Asilom, Jr. ; be it



RESOLVED FURTHER to let certified copies of this Resolution be furnished to the Offices concerned for their information and appropriate action.




