A RESOLUTION ADOPTING THE GUIDELINES ON PREVENTING DOGS AND OTHER PETS FOULING ON PUBLIC PROPERTIES, CITY PARKS AND STREETS.

WHEREAS, Article II, Sections 15-16 of the 1987 Philippine Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them; and, further provides that the State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature;

WHEREAS, Book III, Title III, Chapter 3, Article 1, Section 455 of Republic Act 7160, otherwise known as the Local Government Code of the City of Baybay provides that Local Government Units shall adopt adequate measures to safeguard and conserve land, mineral, marine, forest, and other resources of the City;

WHEREAS, RA 7160 and Article III of Baybay City Ordinance No. 001 series of 2015, otherwise known as the Environment Code of the City of Baybay provides that the City shall ensure an efficient and effective system of solid waste and garbage collection and disposal including the prohibition on littering and the placing or throwing of garbage, refuse and other filth and waste;

WHEREAS, the Baybay City Sangguniang Panlungsod recognizes the need to define guidelines directing and mandating responsible pet owners to prevent fouling and to immediately clean and remove feces of dogs in public properties, city parks and streets;

On motion of Honorable Eden C. Butawan duly seconded by Honorable Alan D. Fernandez and Honorable Leoncio P. Asilom, Jr., be it

RESOLVED, as it is hereby does RESOLVE, to adopt the Guidelines on preventing Dogs and Other Pets Fouling on Public Properties, City Parks and Streets;


RESOLVED FURTHER to let certified copies of this Resolution be furnished to the Offices concerned for their information and appropriate action.


