A RESOLUTION APPROVING THE SUPPLEMENTAL BUDGET OF BARANGAY ZONE 19 IN THE AMOUNT OF ONE HUNDRED FOUR THOUSAND SIX HUNDRED NINETY THREE PESOS AND 61/100 (P104,693.61), BARANGAY IMELDA IN THE AMOUNT OF TWENTY FOUR THOUSAND ONE HUNDRED NINETY SIX PESOS AND 15/100 (P24,196.15), BARANGAY GUADALUPE IN THE AMOUNT OF THREE HUNDRED SIXTY SIX THOUSAND SEVEN HUNDRED SEVENTY PESOS AND 70/100 (P366,770.70), BARANGAY PALHI IN THE AMOUNT OF FORTY NINE THOUSAND FIVE HUNDRED SEVENTY THREE PESOS AND 23/100 (P49,573.23) AND BARANGAY POMPONAN IN THE AMOUNT OF ONE HUNDRED TWENTY FIVE THOUSAND THREE HUNDRED SEVEN PESOS AND 12/100 (125,307.12), ALL OF CITY OF BAYBAY, IN CONFORMITY WITH THE EXISTING LAWS, RULES AND REGULATIONS.
