RESOLUTION NO. 113 S. 2016

A RESOLUTION ASKING THE GENERAL MANAGER AND THE BOARD OF DIRECTORS OF THE BAYBAY CITY WATER DISTRICT TO GIVE AN ACCOUNT IN WRITING WHY NO LEGAL ACTION BE TAKEN AGAINST YOU FOR THE BASELESS, MALICIOUS AND LIBELOUS LETTER DATED JUNE 2, 2016 ADDRESSED TO THE SANGGUNIANG PANLUNGSOD THROUGH THE HONORABLE VICE MAYOR MICHAEL L. CARI...

WHEREAS, the SP members received a letter from the Board of Directors and General Manager of the Baybay City Water District accusing this body of envy , malice, and having an attitude unbecoming of a public official and openly criticizing them to humiliate the members of the board :

WHEREAS, the local government code section 16 state thus: "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants".

WHEREAS, SEC. 458 of 5:V11 of RA 7160 state thus: "Subject to existing laws, establish and provide for the maintenance, repair and operation of an efficient waterworks system to supply water for the inhabitants and to purify the source of the water supply; regulate the construction, maintenance, repair and use of hydrants, pumps, cisterns and reservioirs; protect the purity and quantity of the water supply of the city.

WHEREAS, it is the prime duty this body as part of this local government to ensure the welfare of its constituents in all aspect that may affect them;

WHEREAS, those accusations of the Board of Directors are in itself an insult and thereby degrade the integrity of this body whose members are elected by the people to represent them and only wants to seek solutions to the problems affecting the majority of the people of Baybay;

WHEREFORE, on the motion of all members present; be it:

RESOLVED, as it hereby does RESOLVE, to ask the General Manager and the Bosrd of Directors of the Baybay City Water District to give an account in writing why no legal action be taken against you for the baseless, malicious and libelous letter dated June 2, 2016 addressed through the Sangguniang Panlungsod, through the Honorlable Vice Mayor Michael I. Cari..

RESOLVED, FURTHER, to let certified copies of this resolution be furnished to the General Manager and each members of the Board of Directors of the Baybay City Water District, Local Water Utilities Administration Ombudsman and Civil Service Commission for their information and appropriate action.
