MINUTES OF THE 21st REGULAR SESSION OF THE SANGGUNIANG PANLUNGSOD OF BAYBAY CITY, LEYTE HELD AT THE SESSION HALL ON JUNE 20, 2016.

RESOLUTION NO. 134 S. 2016

A RESOLUTION EXPRESSING PROFOUND REGRET THAT THIS AUGUST BODY CANNOT ACCEPT THE APOLOGY OF THE BOARD MEMBERS OF BAYBAY CITY WATER DISTRICT THROUGH ITS LETTER DATED JUNE 16, 2016 FOR THEIR FAILURE TO APPEAR AND PERSONALLY CONVEY THEIR SINCEREST APOLOGY TO ALL THE SANGGUNIANG PANLUNGSOD MEMBERS.

WHEREAS, this august body was in receipt of a letter dated June 2, 2016 from the board members of the Baybay City Water District which contains malicious, libelous and unfounded statements directed against the august body and threatening its dignity and integrity;

WHEREAS, this august body still entertains the benefit of the doubt that the signatories of said letter did not understand its contents, hence, a resolution was adopted requiring the board to account in writing why no legal action be taken against them for writing an unfounded, baseless, malicious and libelous letter;

WHEREAS, as a response, the members of the board of Baybay City Water District sent instead a letter of apology dated June 16, 2016 to this body;

WHEREAS, the august body deliberated and discussed their letter of apology and noticed that the board did not even explain and give substance their allegations in paragraph 8 thereof which contains the following statements, a portion thereof is reproduced hereunder;

"That there is no truth of ignoring any invitation from the Sangguniang Panlungsod, the truth being, we appeared or send a duly authorized representative despite we noticed an unfriendly atmosphere with few SP members that instead of helping, they tend to become unbecoming as such by criticizing us in public that our services is futile without minding the same is detrimental to the Local Government of Baybay to which they form part of it".


WHEREFORE, on motion all members present; be it:


RESOLVED, FURTHER, to let certified copies of this resolution be furnished to the office concerned for their information and appropriate action.

CARRIED UNANIMOUSLY.


