RESOLUTION NO. 104 Series of 2015

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE CARMEN L. CARI, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF TRADE AND INDUSTRY RELATIVE TO THE SETTING UP OF TIMBANGAN NG BAYAN WEIGHING SCALES AND SCALE HOUSING IN THE PUBLIC MARKET OF THIS CITY.

WHEREAS, under Republic Act No. 7394, otherwise known as the Consumer Act of the Philippines, the City Treasurer implements the provisions thereof relative to the regulation of weights and measures;

WHEREAS, the LGU of Baybay City promotes the use of accurate and calibrated weighing scales in all its public markets in order to protect the consumers in the city;

WHEREAS, the Department of Trade and Industry, in pursuit of its mandate to protect consumers from fraudulent and unconscionable sales practices and acts, adopts measures to ensure that the buying public get value for their money through the use of accurate weighing scales;

WHEREAS, the Department of Trade and Industry has implemented the *Timbangan ng Bayan* project for the installation of accurate weighing scales and scale housing to public market beneficiaries in the different cities and municipalities all over the Philippines;

WHEREAS, the city of Baybay is one of those LGU's whose public markets has been identified as recipients of the Tibangan ng Bayan project;

WHEREFORE, on motion of Honorable Dominador K. Murillo, duly seconded by Honorable Leoncio P. Asilom, Jr and Honorable Alan D. Fernandez; be it:

RESOLVED, as it hereby does RESOLVE, to authorize the City Mayor, Honorable Carmen L. Cari, to enter into a Memorandum of Agreement with the Department of Trade and Industry relative to the setting up of Timbangan ng Bayan weighing scales and scale housing in the public market of this city.

RESOLVED FURTHER, that certified copies of this resolution be furnished to the Office of the City Mayor and the Department of Trade and Industry for information and appropriate action.
