A RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR, DEOGRACIAS E. PERNITEZ AND CITY LEGAL OFFICER, ATTY. JENNIFER BALBOA-CAHIG TO SIGN THE DEED OF SALE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAYBAY AND SPS. FELIPE CARI AND CARMEN L. CARI, IN THE ACQUISITION OF A PORTION OF LOT NO. 1004, OF THE BAYBAY CADASTRE, SITUATED AT BARANGAY KAN-IPA, THIS CITY, CONTAINING AN AREA OF 2,023 SQUARE METERS AND A PORTION OF LOT NO. 1212, BAYBAY CADASTRE, AT SAME BARANGAY, CONTAINING AN AREA OF 874 SQUARE METERS, WHICH PARCELS OF LAND ARE PRESENTLY USED AS PART OF THE DIVERSION ROAD PROJECT AT P170.00/SQ.M. PER SP RESOLUTION NO. 224, S. 2013, DATED NOVEMBER 25, 2013.

RESOLVED, as it hereby does RESOLVE to authorize the City Administrator, Deogoracias E. Pernitez and City Legal Officer, Atty. Jennifer Balboa-Cahig to sign the Deed of Sale executed by and between the City Government of Baybay and Sps. Felipe Cari and Carmen L. Cari, in the acquisition of a portion of Lot No. 1004, Baybay Cadastre, situated at Barangay Kan-ipa, containing an area of 2,023 square meters and a portion of Lot No. 1212, Baybay Cadastre, also at same barangay, containing an area of 874 square meters, which parcels of land are presently used as part of the Diversion Road Project at P170.00/sq.m. per SP Resolution No. 224, s. 2013, dated November 25, 2013.
