A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMEN L. CARI TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) EXECUTED BY AND BETWEEN THE CITY OF BAYBAY, HEREIN REPRESENTED BY HONORABLE CARMEN L. CARI WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, 5TH LEYTE ENGINEERING DISTRICT OFFICE (DPWH) THROUGH EUSEBIO T. CULAS, OIC, OFFICE OF THE DISTRICT ENGINEER, RELATIVE TO THE INSTALLATION OF LAMP POSTS/STREET LAMPS ALONG THE NATIONAL HIGHWAY OF THE CITY.

WHEREAS, the Honorable City Mayor, Carmen L. Cari endorsed to the Body the Memorandum of Agreement between the City of Baybay and the Department of Public Works and Highways Office, relative to the installation of lamp posts/street lamps along the national highway of the city, of which the budget for the 12 km street lights and 8 km poles will funded by the national government, while the 4 km poles will be provided by the City Government of Baybay fund;

WHEREAS, this project is part of the program of the Government to promote and maintain peace, order and security in the community.


WHEREFORE, on motion of the Honorable SP member Honorable Edgardo R. Ompoy, unanimously seconded, be it.
