A RESOLUTION ALLOCATING AN AMOUNT OF EIGHT MILLION ONE HUNDRED NINETY ONE THOUSAND FOUR HUNDRED (P8,191,400.00) COUNTERPART TO THE PRIORITY POVERTY PROJECTS OF THE CITY OF BAYBAY, LEYTE FOR THE CALENDAR YEAR 2015 UNDER THE LOCAL POVERTY REDUCTION ACTION PLAN (LPRAP) APPROVED BY THE NATIONAL GOVERNMENT AND TO UTILIZE SAID FUND FOR THE PURPOSE THEREIN STATED.

WHEREAS, an amount of Eight Million One Hundred Ninety One Thousand Four Hundred Pesos (P8,191,400.00) is hereby appropriated out of 20% Economic Development Fund (EDF) of the Internal Revenue Allotment (IRA) of the city under the General Fund Annual Budget for Calendar Year 2015 of LGU-Baybay for the equity of the Priority Poverty Reduction Projects of the City for the fiscal year 2015 and to utilize said fund for the purpose therein stated the name of projects and the corresponding amount of counterpart/equity hereunder broken down as follows:
