A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HONORABLE CITY MAYOR CARMEN L. CARI TO ENTER INTO A CONTRACT OF SERVICES WITH CANDIDO P. SOMBILON TO SERVE THE CONSTITUENTS OF BAYBAY CITY PARTICULARLY AS THE POINT MAN OF THE GOVERNMENT IN THE CAMPAIGN AGAINST THE RECURRENCE OF LAWLESS ELEMENTS IN THE INTERIOR AND MOUNTAINOUS BARANGAYS FOR A PERIOD OF SIX (6) MONTHS EFFECTIVE JANUARY 1 TO JUNE 30, 2015 WITH A MONTHLY CONTRACT FEE OF FIVE THOUSAND (P5,000.00) PESOS.

On motion of Honorable SP member Atty. Eden C. Butawan and duly seconded by Honorable SP member Edgardo R. Ompoy, be it;

RESOLVED, as it hereby does RESOLVE to authorize the Local Chief Executive, Honorable City Mayor Carmen L. Cari to enter into a Contract of Services with CANDIDO P. SOMBILON to serve the constituents of Baybay particularly as the point man of the government in the campaign against the recurrence of lawless elements in the interior and mountainous barangays for a period of six (6) months effective January 1 to June 30, 2015 with a monthly contract fee of Five Thousand (P5,000.00) pesos.
