A RESOLUTION DECLARING THE SUPPLEMENTAL BUDGET OF BARANGAY AMBACAN IN THE AMOUNT OF FIFTY ONE THOUSAND, FIVE HUNDRED SEVENTY SIX PESOS AND 57/100 (P51,576.57), BARANGAY KAGUMAY IN THE AMOUNT OF TWENTY EIGHT THOUSAND THIRTEEN PESOS AND 57/100 (P28,013.57), BARANGAY HIBUNAWAN IN THE AMOUNT OF TWENTY THOUSAND THREE HUNDRED TWENTY SEVEN PESOS AND 63/100 (P20,327.63), BARANGAY BANAHAO IN THE AMOUNT OF THIRTEEN THOUSAND THREE HUNDRED FIFTY FIVE PESOS AND 89/100 (P13,355.89), BARANGAY KABALASAN IN THE AMOUNT OF TEN THOUSAND SEVEN HUNDRED EIGHT PESOS AND 41/100 (P10,708.41), BARANGAY ZONE 23 IN THE AMOUNT OF FIFTY FOUR THOUSAND TWENTY FOUR PESOS AND 03/100 (P54,024.03), AND BARANGAY GAKAT IN THE AMOUNT OF TWELVE THOUSAND EIGHT HUNDRED EIGHTY ONE PESOS AND 59/100 (P12,881.59) IN CONFORMITY WITH THE EXISTING LAWS, RULES AND REGULATIONS.

RESOLVED, as it hereby does RESOLVE, to declare the supplemental budget of Barangays Ambacan, Kagumay, Hibunawan, Banahao, Kabalasan, Zone 23 and Gakat in the amount of P51,576.57, P28,013.57, P20,327.63, P13,355.89, P10,708.41, P54,024.03 and P12,881.59 respectively, in conformity with the existing laws, rules and regulations.


RESOLVED FURTHER, to let certified copies of this resolution be furnished to the offices concerned for their information and appropriate action.


