MINUTES OF THE 8th REGULAR SESSION OF THE SANGGUNIANG PANLUNGSOD OF BAYBAY CITY, LEYTE HELD AT THE SESSION HALL ON MARCH 2, 2015.

RESOLUTION NO. 081 S. 2015

A RESOLUTION RESPECTFULLY REQUESTING HIS EXCELLENCY BENIGNO SIMEON C. AQUINO 111, PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES TO DECLARE JUNE 16 OF EVERY YEAR AS OFFICIAL LOCAL HOLIDAY IN THE CITY OF BAYBAY TO COMMEMORATE ITS FOUNDING ANNIVERSARY AS A CITY.

WHEREAS, the municipality of Baybay was officially declared as City by virtue of Republic Act 9389 enacted by congress on Feb. 5, 2007;

WHEREAS, the Supreme Court in its final decision on the validity of the said act has given the City of Baybay its imprimatur as a City;

WHEREAS, on June 16, 2007, the people of Baybay through a referendum has voted affirmatively to convert the municipality into a City supervised by the Commission on Election;

WHEREAS, the people of the City of Baybay would like to remember the date as the lasting memory of the future generations through a yearly celebration and commemoration;

WHEREAS, this can only be done through an act in congress and duly approved by the President of the Philippines;

WHEREAS, an act declaring this date would be the legacy of this administration to the people of Baybay;

WHEREFORE, on motion of Honorable Dominador K. Murillo seconded by Hon. Cristelo S. Loreto; be it:

RESOLVED, as it hereby does RESOLVED, to respectfully request His Excellency Benigno Simeon C. Aquino 111, President of the Republic of the Philippines to declare June 16 of every year as official Local Holiday in the City of Baybay to commemorate its founding anniversary as a City.

RESOLVED, FURTHER, to let certified copies of this resolution be furnished to His Excellency Benigno Simeon C. Aquino 111, President of the Republic of the Philippines for his information and appropriate action.
