### RESOLUTION NO. 084 Series of 2015

**A RESOLUTION RESPECTFULLY REQUESTING THE MANAGEMENT OF BAYBAY WATER DISTRICT TO RELEASE/REMIT TO THE BARANGAY TREASURERS OF BARANGAY VILLA MAG-ASO AND BARANGAY PATAG THE CORRESPONDING 35% SHARES OF 1% OF THE GROSS SALES OR RECEIPTS FROM THE UTILIZATION OF WATER SOURCES LOCATED IN THEIR RESPECTIVE BARANGAYS FOR THE YEARS FROM 2011 TO 2014 AND 2012 TO 2014 RESPECTIVELY,**

WHEREAS, the barangay where the source of water located shall receive a 35% of 1% share of the gross receipts as mandated by law;

WHEREAS, the said barangays declared that they did not receive their shares for the period stated above;

WHEREAS, these barangays have already submitted their letter complaints to the Baybay Water District for appropriate action;



RESOLVED, as it hereby does RESOLVE, to respectfully request the management of Baybay Water District to release/remit to the barangay treasurers of Barangay Villa Mag-aso and Barangay Patag the corresponding 35% shares of 1% of the gross sales or receipts from the utilization of water sources located in their respective barangays for the years from 2011 to 2014 and 2012 to 2014 respectively.,


RESOLVED FURTHER, that certified copies of this resolution be furnished to the Manager of Baybay Water District for their information and appropriate action.

CARRIED UNANIMOUSLY.




