RESOLUTION NO. 016 S. 2017

A RESOLUTION AUTHORIZING THE CITY MAYOR CARMEN L. CARI, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE CITY SOCIAL WELFARE AND DEVELOPMENT (CSWD) COVERING THE FOLLOWING PROGRAMS:

1. Supplementary Feeding Program
2. Pantawid Pamilyang Pilipino Program
3. Sustainable Livelihood Program
4. Kapit-bisang Laban sa Kahirapan-Comprehensive Integrated Delivery of Social Services (KALAHI-CIDSS)
5. Bottom-Up Budgeting Projects

WHEREAS, the City Social Welfare and Development (CSWD) is the government agency that is primarily responsible in delivering coordinated social protection services aimed at eradicating poverty;

WHEREAS, CSWD envisions a society where the poor, vulnerable and disadvantaged individuals, families, and communities are empowered for an improved quality of life;

WHEREAS, CSWD takes protection of the poor and marginalized as its main mission which it seeks to achieve through the implementation of various projects, programs, and activities collectively referred to as "Social Protection";

WHEREAS, the Local Government Units are mandated by law to address the needs of its constituents, empower its people and allow them widest possible participation in government affairs;

WHEREAS, the City Government intends to address the poverty of its citizens through the implementation of programs, locally generated or in coordination with National Government Agencies;

WHEREAS, the City Government recognizes that the projects being implemented by CSWD are designed to deliver coordinated social protection services and are aimed at addressing poverty;

5. Bottom-Up Budgeting Projects.


RESOLVED, FURTHER, to let certified copies of this resolution be furnished to the office concerned for their information and appropriate action.


