- PATAG IN THE AMOUNT OF ONE MILLION EIGHT HUNDRED EIGHTEEN THOUSAND FIVE HUNDRED NINETY-FOUR (P1,818,594.00) PESOS;
- PUNTA IN THE AMOUNT OF ONE MILLION SIX HUNDRED EIGHTY-NINE THOUSAND ONE HUNDRED TEN (P1,689,110.00) PESOS;
- HIPUSNGO IN THE AMOUNT OF TWO MILLION FIVE HUNDRED SEVENTY-TWO THOUSAND ONE HUNDRED FIFTY-NINE (P2,572,159.00) PESOS;
- PALHI IN THE AMOUNT OF TWO MILLION THREE HUNDRED FORTY-TWO THOUSAND EIGHTY-EIGHT (P2,342,088.00) PESOS; AND
- ZONE 12 IN THE AMOUNT OF ONE MILLION FOUR HUNDRED EIGHT THOUSAND FOUR HUNDRED SIXTY-EIGHT (P1,408,468.00) PESOS.

On motion of Honorable ABC President, Mandy G. Muñoz and duly seconded by Honorable SP Member Edgardo R. Ompoy, be it;




