**RESOLUTION NO. 19, S. 2017**

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMEN L. CARI TO APPROPRIATE FUNDS FOR THE PURCHASE OF EIGHT (8) UNITS MOTOR VEHICLES FOR THE FOLLOWING PURPOSES AND PARTICULARS:

1) Two (2) units Multi-cab with engine displacement of 660cc, 3-cylinders, 2 seaters and diesel-fed for the **City Planning and Development Office (CPDO)** to be used for inspections and surveying of city infrastructures of all the 92 barangays, for transporting equipment and facilitate official travels relative to CPDO activities;

2) One (1) unit 4 x 4 Pick Up Vehicle with engine displacement of 2, 494cc, 4 cylinders, 5-seaters and diesel-fed for the **City Engineering Office (CEO)** for transportation purposes of office personnel in conducting field works, project inspection, transporting equipment and to facilitate for official travels relative to CEO activities;

3) One (1) unit Passenger Van, engine displacement of 2,494cc, 4 – cylinders, diesel-fed, and 15 seaters for the **City Tourism and Investment Promotion Office** to provide ready transportation for the satisfaction of tourists, especially the PWD's, Senior Citizens and/or pregnant women, and also as transportation of office personnel during investment site inspection and validation;

4) One (1) unit Multi-purpose vehicle with engine displacement of 2,665cc, 4 cylinders, 18-seaters and diesel-fed for official use of the **City Social Services and Development Office (CSWDO)** to serve for transportation purposes during the monitoring and evaluation of Daycare services, livelihood programs; organizing the youths and women; deliver relief goods to different barangays in time of disaster; transport physically disabled and mentally retarded patients and for official travels of CSWDO personnel.

5) One (1) unit Multi-purpose vehicle with engine displacement of 2,477cc, 4 – cylinders, 18-seaters and diesel-fed for the **Gender and Development (GAD) Office** to be used for transportation purposes in securing raw materials and implementing the Jackfruit Project of the LGU; in monitoring and evaluation of various projects funded by GAD; to transport equipment and personnel during trainings/seminars, forums and similar activities within and outside the city and for official travels/trips of GAD personnel, especially in times of emergency, disasters and other unwarranted circumstances that may be deemed legally appropriate and justifiable.

6) One (1) unit Multi-purpose vehicle with engine displacement of 2,665cc, 4-cylinders OHV, diesel – fed, 18 seaters for official use of the **City Agriculture Office** for transportation purposes in carrying out various programs and services for the implementation of projects funded by the City Agriculture Office, facilitate guests and clients within and outside the city; for trips in cases of emergency, disasters and other unwarranted circumstances for human consideration that may be deemed legal appropriate and justifiable.

7) One (1) unit brand new Garbage Compactor, 4 x 2 with engine model DE12TIS to be used to facilitate implementation of the Solid Waste Management Program of the Baybay City Local Government.

On motion of Honorable SP Member Edgardo R. Ompoy and duly seconded by Honorable SP Member Filemon F. Avila, be it;

RESOLVED, as it hereby does RESOLVE, to authorize the Honorable City Mayor Carmen L. Cari to appropriate funds for the purchase of eight (8) units motor vehicles for the following purposes and particulars:

3) One (1) unit Passenger Van, engine displacement of 2,494cc, 4 – cylinders, diesel-fed, and 15-seaters for the **City Tourism and Investment Promotion Office** to provide ready transportation for the satisfaction of tourists, especially the PWD's, Senior Citizens and/or pregnant women, and also as transportation of office personnel during investment site inspection and validation;

4) One (1) unit Multi-purpose vehicle with engine displacement of 2,665cc, 4 cylinders, 18-seaters and diesel-fed for official use of the **City Social Services and Development Office (CSWDO)** to serve for transportation purposes during the monitoring and evaluation of Daycare services, livelihood programs; organizing the youths and women; deliver relief goods to different barangays in time of disaster; transport physically disabled and mentally retarded patients and for official travels of CSWDO personnel.



7) One (1) unit brand new Garbage Compactor, 4 x 2 with engine model DE12TIS to be used to facilitate implementation of the Solid Waste Management Program of the Baybay City Local Government.


