## **RESOLUTION NO. 33, S. 2017**

A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE CARMEN L. CARI TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) ON BEHALF OF THE CITY GOVERNMENT OF BAYBAY CITY, LEYTE WITH THE PHILIPPINE NATIONAL POLICE (PNP) REGIONAL OFFICE, REPRESENTED BY ITS REGIONAL DIRECTOR, PC/SUPT ELMER C. BELTEJAR, TO ALLOCATE THE SUM OF SEVENTY THOUSAND (P70,000.00) PESOS TO DEFRAY THE EXPENSES FOR PNP BAYBAY CITY PERSONNEL WHO WERE RECOMMENDED TO PARTICIPATE IN THE POST BLAST INVESTIGATION TRAINING AT THE PNP NATIONAL HEADQUARTERS, CAMP CRAME, QUEZON CITY.

On motion of Honorable SP Member Arturo Elisa O. Astorga and duly seconded by Honorable SP Member Vicente Victor G. Veloso, be it;

RESOLVED, as it hereby does RESOLVE, to authorize the City Mayor, Honorable Carmen L. Cari to enter into a Memorandum of Agreement (MOA) on behalf of the City Government of Baybay City, Leyte with the Philippine National Police (PNP) Regional Office, represented by its Regional Director, PC/Supt. Elmer C. Beltejar, to allocate the sum of Seventy Thousand (P70,000.00) pesos to defray the expenses for the PNP Baybay City Personnel who were recommended to participate in the Post Blast Investigation Training at the PNP National Headquarters, Camp Crame, Quezon City.

RESOLVED FURTHER, that certified copies of this resolution be furnished to all offices and agencies concerned for their information and appropriate action.
