A RESOLUTION INFORMING THE LAND BANK OF THE PHILIPPINES (LBP), BAYBAY CITY BRANCH OF THE CONSENSUS OF THIS AUGUST BODY NOT TO PUSH THROUGH WITH THE LOAN APPLICATION CONSIDERING THAT THE AMOUNT INITIALLY APPROVED BY THE LAND BANK OF THE PHILIPPINES (LBP), BAYBAY CITY BRANCH, WAS NOT THE ORIGINAL AMOUNT APPLIED FOR BY THIS LOCAL GOVERNMENT UNIT, THUS, IT CANNOT FINANCE THE BUDGETARY REQUIREMENT OF THE INTENDED PROJECTS.


On motion of Honorable SP Member Atty. Ernesto M. Butawan and duly seconded by all the other members of this honorable body, be it;

RESOLVED, as it hereby does RESOLVE, to inform the Land Bank of the Philippines (LBP), Baybay City Branch of the consensus of this august body not to push through with the loan application considering that the amount initially approved by the Land Bank of the Philippines (LBP), Baybay City Branch, was not the original amount applied for by this Local Government Unit, thus, it cannot finance the budgetary requirement of the intended projects.


RESOLVED FURTHER, that certified copies of this resolution be furnished to all offices and agencies concerned for their information and appropriate action.






