Resolution No. 004 January 24, 2017

A RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM THE LOCAL GOVERNMENT UNIT (LGU) OF BAYBAY CITY THROUGH HONORABLE MAYOR CARMEN L. CARÍ FOR THE CONSTRUCTION OF ADDITIONAL WATER IMPOUNDING FACILITY (RESERVOIR) IN BARANGAY COGON BAYBAY CITY, LEYTE

- WHEREAS, the demand of potable water supply and pressure had increased more specially in the Poblacion area where many business establishments are located;
- WHEREAS, the Baybay City Water District made a Development Plan for the year 2017 to address the growing demand of water supply and pressure to the mandated service area;
- WHEREAS, the Baybay City Water District plans to construct additional water impounding facility (reservoir) adjacent to the existing reservoir at Barangay Cogon, Baybay City, Leyte to alleviate the problem of water supply and pressure especially during bad weather conditions wherein the water sources are affected;
- WHEREAS, the Baybay City Water District acknowledges its financial incapacity to materialize this plan and deems it necessary to request for financial assistance from other financial sources such as from the Local Government Unit of Baybay;
- WHEREFORE, on a motion made by Director Atty. Eden C. Butawan duly seconded by Director Vicente M. Alkuino and other members of the Board of Directors, be it,
- RESOLVED, as it is hereby resolved to request for financial assistance from the Local Government Unit of Baybay through Hon. Mayor Carmen L. Cari for the construction of additional water impounding facility (reservoir) in Barangay Cogon, Baybay City, Leyte;
- RESOLVED further, to let copies of this resolution be furnished to the General Manager and the Hon. Mayor Carmen L. Cari for their information.
