



## BARANGAY VILLA SOLIDARIDAD

BARANGAY ORDINANCE NO. 2  
INTRODUCED BY HON. COUNCILOR ELWIN B. ABALO

AN ORDINANCE IMPOSING FEES FOR THE RENTAL OF THE TALIPAPA FOR THE RESIDENTS OF BARANGAY VILLA SOLIDARIDAD.

BE IT ORDAINED BY THE SANGGUNIANG BARANGAY OF VILLA SOLIDARIDAD BAYBAY CITY, LEYTE IN ASSEMBLED THAT:

**SECTION 1.** THIS ORDINANCE IS ENACTED IN ORDER TO IMPOSE RENTAL OF THE BARANGAY TALIPAPA BY RESIDENTS OF OUR BARANGAY. THE PROCEEDS FROM SAID FEES SHALL BE USED SOLELY FOR THE MAINTENANCE AND UPKEEP OF THE BARANGAY TALIPAPA.

**SECTION 2.** THOSE WHO WANT TO AVAIL OF THE BARANGAY TALIPAPA, WILL PAY THE FOLLOWING FEES AS PARTICULARS:

1. TABLE WITH ELECTRICITY USE = P20.00
2. TABLE WITH NO ELECTRICITY USE = P5.00
3. MEAT/ FISH VENDORS WHO WOULD ENTER CURVA 2 WILL BE PAY A TICKET OF P10.00 .

**SECTION 3.** ANY ORDINANCE OR RESOLUTION CONTRARY TO THIS ORDINANCE IS HEREBY REPEALED.

**SECTION 4.** THIS ORDINANCE SHALL HAVE A SPECIAL ACCOUNT AND ACCOUNTABLE BY THE COMMITTEE OF FINANCE HON. ELWIN B. ABALO, AND ANY PAYMENTS MUST HAVE AN OFFICIAL RECIEPT TO BE ISSUED.

**SECTION 5.** THIS ORDINANCE SHALL TAKE EFFECT IMMEDIATELY UPON ITS APPROVAL BY THE SANGGUNIANG BAYAN OF THE BAYBAY CITY LEYTE.

RESOLVED FURTHER, TO LET CERTIFIED COPIES OF THIS ORDINANCE BE FURNISHED TO SANGGUNIANG BAYAN OF BAYBAY CITY, LEYTE AND OTHER CONCERNED OFFICES FOR THEIR INFORMATION AND RECORD.
