RESOLUTION NO. 124, S. 2017

A RESOLUTION AUTHORIZING HONORABLE CITY MAYOR CARMEN L. CARI, ON BEHALF OF THE CITY GOVERNMENT OF BAYBAY TO ENTER INTO A CONTRACT OF SERVICE WITH DR. MONICO J. CARAWANA, M.D., TO PROVIDE SERVICES TO THE CONSTITUENTS OF THIS CITY, AS PHYSICIAN ON DUTY AT THE BAYBAY CITY MEDICAL DIAGNOSTIC AND DIALYSIS CENTER (BCMDDC) FOR THE PERIOD COVERING APRIL 1, 2017 TO MARCH 31, 2018 FOR A CONTRACT FEE OF THIRTY-TWO THOUSAND (P32,000.00) PESOS PER MONTH.

On motion of Honorable SP Member Atty. Ernesto M. Butawan, and duly seconded by Honorable SP Member Vicente Victor G. Veloso, Rodolfo S. Palma, Jr., and Filemon F. Avila, be it;

RESOLVED, as it hereby does RESOLVE, to authorize the Honorable City Mayor Carmen L. Cari to enter into a Service Contract on behalf of the City Government of Baybay with Dr. Monico J. Carawana, M.D., to provide services to the constituents of this city, as Physician on Duty at the Baybay City Medical Diagnostic and Dialysis Center (BCMDDC) for the period covering April 1, 2017 to March 31, 2018 for a contract fee of Thirty-two Thousand (P32,000.00) pesos per month.


RESOLVED FURTHER, that certified copies of this resolution be furnished to all offices and agencies concerned for their information and appropriate action.


