## RESOLUTION NO. 145 Series of 2017

A RESOLUTION ADOPTING THE SUPPLEMENTAL BUDGET NO. 01, SERIES OF 2017 OF THE CITY OF BAYBAY IN THE AMOUNT OF ONE HUNDRED SIXTY-FIVE MILLION (P165-M) PESOS.

Presented for consideration was Supplemental Budget No. 01 submitted by the Honorable City Mayor Carmen L. Cari, with a total amount of ONE HUNDRED SIXTY-FIVE MILLION (P165,000,000.00) PESOS, which the honorable members of this august body, after a careful perusal and financial examination deemed that the aforementioned budget is in accordance with law.

On motion of Honorable SP Member Edgardo R. Ompoy, and duly seconded by all the members of this council, be it;

RESOLVED, as it hereby does RESOLVE, that the Appropriation Ordinance be, as hereby is, adopted to wit:

## **APPROPRIATION ORDINANCE NO. 01. SERIES OF 2017**

AN ORDINANCE ADOPTING THE SUPPLEMENTAL BUDGET NO 01 FOR CALENDAR YEAR 2017 OF THE CITY OF BAYBAY, LEYTE, IN THE TOTAL AMOUNT OF ONE HUNDRED SIXTY-FIVE MILLION (P165,000,000.00) PESOS.

Be it ordained by the Sangguniang Panlungsod of the City of Baybay, Province of Leyte in session assembled, that:

Section 1. The Sum of ONE HUNDRED SIXTY-FIVE MILLION (P165,000,000.00) PESOS Is hereby declared for Supplemental Budget from the current year's General Fund.

Section 2. This Ordinance shall take effect upon its approval.
