**AN ORDINANCE ADOPTING THE SUPPLEMENTAL BUDGET NO 01 FOR CALENDAR YEAR 2017 OF THE CITY OF BAYBAY, LEYTE, IN THE TOTAL AMOUNT OF ONE HUNDRED SIXTY-FIVE MILLION (P165,000,000.00) PESOS.**

Be it ordained by the Sangguniang Panlungsod of the City of Baybay, Province of Leyte in session assembled, that:

Section 1. The Sum of ONE HUNDRED SIXTY-FIVE MILLION (P165,000,000.00) PESOS Is hereby declared for Supplemental Budget from the current year's General Fund.


Section 2. This Ordinance shall take effect upon its approval.

Enacted, April 17, 2017.


RESOLVED FURTHER, that certified copies of this resolution be furnished to the offices concerned for their information and appropriate action.
