A RESOLUTION AUTHORIZING THE CITY MAYOR, HONORABLE CARMEN L. CARI ON BEHALF OF THE CITY GOVERNMENT OF BAYBAY TO ENTER INTO A DEED OF SALE FOR THE PURCHASE OF THE FOLLOWING PARCELS OF LAND:

- LOT NO. 3998-A, CONTAINING AN AREA OF 16,996 SQM;
- LOT NO. 3998-B, CONTAINING AN AREA OF 23,854 SQM ;
- LOT NO. 3998-C, CONTAINING AN AREA OF 6,958 SQM;
- LOT NO. 3995-D, CONTAINING AN AREA OF 3,010 SQM;
- LOT NO. 3995-J, CONTAINING AN AREA OF 3,009 SQM;
- LOT NO. 3995-K, CONTAINING AN AREA OF 3.009 SQM; and
- LOT NO. 3995-L, CONTAINING AN AREA OF 3,009 SQM.

ALL AT ONE THOUSAND FOUR HUNDRED (P1,400.00) PESOS PER SQUARE METER IN ACCORDANCE WITH THE ASSESSMENT OF THE CITY APPRAISAL COMMITTEE FOR A GOVERNMENT PROJECT:



RESOLVED, as it hereby does RESOLVE, to authorize the City Mayor, Honorable Carmen L. Cari on behalf of the City Government of Baybay to enter into a Deed of Sale for the purchase of the following parcels of land: Lot No. 3998-A containing an area of 16,996. sq.m; Lot No. 3998-B containing an area of 23,854 sqm.; Lot No. 3998-C containing an area of 6,958 sqm; Lot No. 3995-D containing an area of 3,010 sqm; Lot No. 3995-J containing an area of 3,009 sqm; Lot No. 3995-K containing an area of 3,009 sqm; and Lot No. 3995-L containing an area of 3,009 sqm, ALL at One Thousand Four Hundred (P1,400.00) pesos per sqm in accordance with the assessment of the City Appraisal Committee for a government project.
