- BANAHAO IN THE AMOUNT OF ONE MILLION FOUR HUNDRED SEVEN THOUSAND THREE HUNDRED FIFTY-SIX (P1,407,356.00) PESOS;
- JAENA IN THE AMOUNT OF ONE MILLION FOUR HUNDRED FORTY THOUSAND ONE HUNDRED FORTY-FOUR (P1,440,144.00) PESOS;
- PANGASUGAN IN THE AMOUNT OF TWO MILLION FOUR HUNDRED THOUSAND (P2,400,000.00) PESOS;
- KANTAGNOS IN THE AMOUNT OF ONE MILLION TWO HUNDRED SEVENTY-SEVEN THOUSAND THREE HUNDRED SIXTEEN (P1,277,316.00) PESOS;
- ZONE 15 IN THE AMOUNT OF ONE MILLION NINE HUNDRED SIX THOUSAND ONE HUNDRED FORTY-NINE (P1,906,149.00) PESOS; AND
- AMPIHANON IN THE AMOUNT OF ONE MILLION THREE HUNDRED SIX THOUSAND TWO HUNDRED FOURTEEN (P1,306,214.00) PESOS


RESOLVED FURTHER, that certified copies of this resolution be furnished to all offices and agencies concerned for their information and appropriate action.


