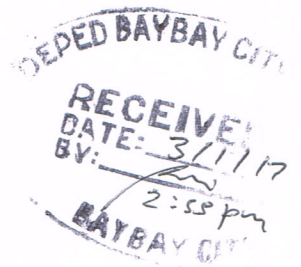


On motion of Honorable SP Member Leoncio P. Asilom, Jr. and duly seconded by SP Member Alan D. Fernandez, be it;


RESOLVED FURTHER, that certified copies of this resolution be furnished to all offices and agencies concerned for their information and appropriate action.

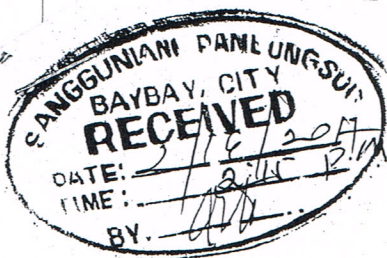

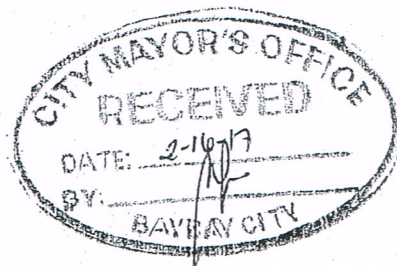

WHEREAS, Barangay Igang has 2 big nearby barangays (Maganhan and Kantagnos) where students experienced the same problem with the students of Igang in going to distant high school;


WHEREAS, the Igang Elementary School has 1 available classroom and wide buildable space for 8 new classrooms for the possible opening of high school classes, through school expansion;

RESOLVED FURTHER, that the copy of this resolution be furnished to the office of the City Mayor and Office of the Sangguniang Panglungsod for appropriate action.


