
On motion of Honorable SP Member Alan D. Fernandez, and duly seconded by Honorable SP Member Jorge V. Rebucas, be it;


RESOLVED FURTHER, that certified copies of this resolution be furnished to all offices and agencies concerned for their information and appropriate action.
