- MONTERICO IN THE AMOUNT OF ONE MILLION TWO HUNDRED ONE THOUSAND SEVEN HUNDRED THIRTY-EIGHT (P1,201,738.00) PESOS; AND
- ZACARITO IN THE AMOUNT OF ONE MILLION TWO HUNDRED TWENTY THOUSAND SEVENTY-SIX (P1,220,076.00) PESOS,




RESOLVED FURTHER, that certified copies of this resolution be furnished to all offices and agencies concerned for their information and appropriate action.


