**RESOLUTION NO. 65, 2017**

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR CARMEN L. CARI TO ENTER INTO A DEED OF USUFRUCT ON BEHALF OF THE CITY GOVERNMENT OF BAYBAY WITH THE DEPARTMENT OF EDUCATION, REPRESENTED BY THE CITY SCHOOLS DIVISION SUPERINTENDENT OF LEYTE, DR. GENIS S. MURALLOS, CESO V, FOR THE CONSTRUCTION OF IGANG INTEGRATED SCHOOL, BARANGAY IGANG, THIS CITY, ON BAYBAY CADASTRAL LOT NO. 041, CONTAINING AN AREA OF ONE THOUSAND SEVEN HUNDRED FORTY-ONE (1,741) SQ. METERS MORE OR LESS, THE SITE WHERE IGANG ELEMENTARY SCHOOL IS LOCATED.

On motion of SP Member Atty. Ernesto M. Butawan and duly seconded by Hon. SP Members Vicente Victor G. Veloso and Jorge V. Rebucas, be it;

RESOLVED, as it hereby does RESOLVE, to authorize the Honorable City Mayor Carmen L. Cari to enter into a Deed of Usufruct on behalf of the City Government of Baybay with the Department of Education, represented by the City Schools Division Superintendent of Leyte, Dr. Genis S. Murallos, CESO V, for the construction of Igang Integrated School, Barangay Igang, this city, on Baybay Cadastral Lot No. 041, containing an area of One Thousand Seven Hundred Forty-one (1,741) sq. meters more or less, the site where Igang Elementary School is located.


