RESOLUTION NO. 73, S. 2017

A RESOLUTION CONFIRMING AND ATTESTING TO THE FACT THAT CADASTRAL LOT NOS. 4786 & 4726 OF BARANGAY BUENAVISTA, THIS CITY, CONTAINING A TOTAL LAND AREA OF THIRTY-FOUR THOUSAND FIVE HUNDRED EIGHT (34,508) SQ.M. MORE OR LESS, BEING THE SUBJECT OF CITY ORDINANCE NO. 010, S. 2016, EACH IS A PARCEL OF LAND THAT HAS A SUBSTANTIALLY GREATER VALUE FOR RESIDENTIAL, COMMERCIAL OR INDUSTRIAL PURPOSES AS DETERMINED BY THIS SANGGUNIAN, HENCE, THESE LOTS MEET THE STANDARD REQUIREMENT FOR RECLASSIFICATION FROM COMMERCIAL TO PARK AND RECREATION ZONE CATEGORY.

On motion of the Honorable SP Member Atty. Ernesto M. Butawan and duly seconded by all the members of this august body, be it;

RESOLVED, as it hereby does RESOLVE, to confirm and attest to the fact that Cadastral Lot Nos. 4786 & 4726 of Barangay Buenavista, this city, containing a total land area of Thirty-four Thousand Five Hundred Eight (34,508) square meters more or less, under TCT No. 16152, being the subject of City Ordinance No. 010, s. 2016, each is a parcel of land that has a substantially greater value for residential, commercial or industrial purposes as determined by this Sanggunian, hence, these lots meet the standard requirement for reclassification from a Commercial to Park and Recreation Zone category.


RESOLVED FURTHER, that certified copies of this resolution be furnished to all offices and agencies concerned for their information and appropriate action.

CARRIED UNANIMOUSLY.


