RESOLUTION NO. 77, S. 2017

A RESOLUTION RESPECTFULLY REQUESTING LAND BANK OF THE PHILIPPINES (LBP), BAYBAY CITY BRANCH, THROUGH ITS BRANCH MANAGER, MS. ANUNCIACION ELENA D. DICO, TO CHANGE THE ACCOUNT NAME OF BAYBAY MEDICAL DIAGNOSTIC CENTER TO BAYBAY CITY MEDICAL DIAGNOSTIC AND DIALYSIS CENTER UNDER THE SAME ACCOUNT NUMBER 3572-1021-56.

WHEREAS, per SP Resolution No. 108, series of 2016, the Baybay City Medical Diagnostic and Dialysis Center was created;

WHEREAS, prior to its creation by virtue of the said Resolution No. 108, the medical institution was temporarily called, Baybay Medical Diagnostic Center;

WHEREAS, when Baybay Medical Diagnostic Center started its initial operation, it opened a Savings Account with Land Bank of the Philippines (LBP), Baybay City Branch, bearing Account Number 3572-1021-56 under Account Name Baybay Medical Diagnostic Center;

WHEREAS, the said Baybay Medical Diagnostic Center is now officially named as the Baybay City Medical Diagnostic and Dialysis Center (BCMDDC).



CARRIED UNANIMOUSLY.


