## **RESOLUTION NO. 85, S. 2017**

A RESOLUTION ENDORSING TO THE CPDO, THROUGH ENGR. PATRICK A. POSTRERO, THE HEREIN RESOLUTION NO. 1, SERIES OF 2017 OF BARANGAY MARCELO GALENZOGA (ZONE 1), THIS CITY, TO CONDUCT RELOCATION SURVEY OF THE OLD SPANISH ROAD, CONTAINING AN AREA OF 40 SQUARE METERS, LOCATED ADJACENT THE FOLLOWING ADJOINING LOTS: ZONE 1 BARANGAY HALL, LOT NO. 450 DECLARED IN THE NAME OF LEONORA STA. IGLESIA AND A PARCEL OF LOT DECLARED IN THE NAME OF JUANARIO FLANDEZ; AND DETERMINE THE EXISTENCE OF ACTUAL OCCUPANTS OR ANY PHYSICAL IMPROVEMENTS THEREON.

Iglesia and a parcel of lot declared in the name of Juanario Flandez; and determine the existence of actual occupants or any physical improvements thereon.
