RESOLUTION NO. 93, S. 2017

- TITLE NO. T-36875: ROAD LOT 7625-B, Psd-08-024881-D, A PORTION OF LOT NO. 7625, Psc-5, WITH AN AREA OF 214 SQM., ALL SITUATED AT BARANGAY MARCOS, BAYBAY CITY.




RESOLVED FURTHER, that certified copies of this resolution be furnished to all offices and agencies concerned for their information and appropriate action.


