MUNICIPAL ORDINANCE NO. 001 S. 2004

AN ORDINANCE AMENDING MUN. ORDINANCE NO. 008 S. 1996, THIS MUNICIPALITY EXTENDING ADDITIONAL ASSISTANCE TO THE BARANGAY POLICE AUXILLARIES FROM P3,000.00 DEATH BENEFITS AND P1,000.00 BURIAL BENEFITS TO EACH MEMBER TO P5,000.00 AND P3,000.00 RESPECTIVELY AND HOSPITALIZATION BENEFITS FROM P30.00 TO P100.00/DAY.

WHEREAS, it has been brought to the attention of this Sanggunian that the Barangay Police Auxillaries have no coverage as a form of assistance for any cause of death;

WHEREAS, this Sanggunian, in the exercise of its role and in the light of the "General Welfare Clause" of the Philippine Constitution, as well as the Local Government Code of 1991, saw it proper and fitting to extend assistance fund to these barangay Police Auxillaries.

NOW, THEREFORE,

Be it ordained by the Sangguniang Bayan of the Municipality of Baybay, Province of Leyte, in session assembled, that:

Section 1.- Definition of Terms - for purposes of this ordinance, the following terms are hereby defined, as follows:

BARANGAY POLICE AUXILLARIES ASSISTANCE FUND

BENEFITS:

In case of death due to any cause, P5,000.00

1. Accident Hospital Income benefit:

Hospitalization due to accident on duty.

A member while confined in the hospital shall receive P100.00 per day but not more than P3,000.00, equivalent to 30 days confinement in the hospital.

2. Burial Benefit of P3,000.00 for each member

Section 2. - Accreditation fee of P20.00 annually shall be charged/collected per Barangay Police Auxillary Member, with acceptable ages -21 to 60 years old. The total amount of accreditation fees collected shall be deposited with the trust fund account.

Section 3. - Identity of Barangay Police Auxillary is all barangays, duly appointed by the Barangay Captain, shall in his position the appointment paper, the Oath of Office and ID Card, and a masterlist of all the Barangay Police Auxillaries shall be kept in the Office of the Association of Barngay Councils, PROVIDED, that a copy of the updated masterilist of the Barangay Police Auxillaries shall be furnished the Office of the Mayor and SB Office every January of the following year, PROVIDED, FURTHER, that the maximum number of Barangay Police Auxillaries per barangay shall not exceed twenty (20) members as provided in Section 393 of the Local Government Code of 1991.

Section 4. - that the amount required be appropriated annually and PROVIDED FURTHER that the trust fund be maintained by this purposes.

Section 5. - Repealing Clause - Any rule, regulation or ordinance inconsistent to this ordinance is hereyby repealed accordingly.

Section 6. - Effectivity.- for this purpose, upon approval and effectivity of this ordinance all barangays, through their Barangay Captains shall submit to the Office of the Association of Barangay Councils, which is authorized to formulate procedure in its implementation, their respective lists of all appointed Barangay Police Auxillaries.
